Rules and how to qualify for awards.

Please read carefully.

1. Hot Wing Cook-Off Categories

2. Ingredients & Preparation

In order to ensure the wings are freshly thawed and have the same quality of meat please use non-breaded or naked wings only. If you would like to bread them yourself please do so. **Failure to do so will result in instant disqualification from the competition.** It is suggested that each team make at least **10lbs.** of wings for the competition.

******This is a non-traditional cook-off competition and everything must be cooked OFF-SITE no earlier than 6 hours prior to the judging start time (1pm Saturday, May 4, 2013 Chicken wings must be cooked from the raw state with no pre-marinating or pre-injecting. Any seasoning or ingredient necessary to create unique taste is acceptable but MUST be listed at your table. Signage for levels of hotness **MUST** also be listed at your table 1-10 scale, 10 being the hottest of the hot!!!**

Electricity will NOT be provided on-site so please make sure you bring sterno's for chaffing dishes, an ice chest, and/or whatever else you may need to serve them hot (croc-pots are not allowed)!

3. Cooking

Teams must bring their own serving utensils, equipment, paper towels, and all other necessary equipment. This includes signage, tent, tables, chairs, and whatever else you may need for your booth. A MINIMUM of 10lbs. of wings is required, but the more the merrier!!!!

4. Selling

Crime Stoppers of Tangipahoa will begin selling wristbands at 1pm for the public to sample your wings and determine the People's Choice Award winner until you run out of product. All proceeds from the sale of the wristbands will be benefit Crime Stoppers of Tangipahoa, Inc.. Wristbands will be sold for \$10.00 and will include a drink and a People's Choice Award ballot. Take-out trays and drinks will be provided by Piggly Wiggly.

5. Judging

Ballots will determine the winner of the People's Choice Award. The ballots will be

available for purchase with a wristband and drink at the cook-off registration table for \$10.00 each. All other awards will be determined by a panel of secret judges with wristbands who will visit your booth and sample your wings along with everyone else. You will not know who they are. Contestants will be advised of when judging begins (NOON) and when awards will be presented(TBD).

6. Prizes

Prizes are non-transferable nor redeemable for cash.

7. Registration

Upon arrival at the cooking site (1530 SW RR Ave, Hammond, LA 70403), the team captain must check in with Chairman at the Cook-off registration table for area assignment. **The Registration table will be open at 11:00 a.m. at which time you may set up your booth.** At that time we will provide you with any new information concerning the cook off.

8. Booth Set-up

Set-up time may begin at 11:00 a.m., which gives you two hours to prep for the start time at 1:00 p.m., judging will not begin until 1pm. Public displays and demonstrations are encouraged in order to involve the crowd. However, decorations are not mandatory.

9. Booth Teardown

Areas must be cleaned up at the end of the event (4:00 p.m.). All equipment must be off the premises by 5:00pm.

10. Application & Fees

Cook Off applications and fees must be postmarked by **MONDAY, APRIL 28, 2013**. All fees can be made payable to **CRIME STOPPERS OF TANGIPAHOA, INC.**. All entry fees are non-refundable. All proceeds will benefit Crime Stoppers of Tangipahoa, Inc., a 501c3 non-profit organization and United Way Community Partner agency (TAX ID: 68-0516834). Entry fees may also be paid online at www.tangicrimestoppers.com/events , however, your copy of these forms must be mailed in with proof of online payment postmarked no later than April 28th, 2013.
