2013 Hot Wing Cook-Off Challenge RULES

Please read carefully & keep this copy. Rules are subject to change.

1. Hot Wing Cook-Off Categories (Restaurant & Individual/Teams Categories):

Best Traditional Wing Sauce

Most Creative Wing Sauce

Hottest of the Hot

Best Decorated Booth/Team Theme

People's Choice

Big Tipper Award

**** A Trophy and Prize will be given for each award listed above in both the Restaurant and Individual Categories.**

2. Ingredients & Preparation - In order to ensure the wings are freshly thawed and have the same quality of meat please use non-breaded or naked wings only. If you would like to bread them yourself please do so. **Failure to do so will result in instant disqualification from the competition.** It is suggested that each team make at least **10lbs.** of wings for the competition. (But the more wings the merrier!)

******This is a TRADITIONAL COOK-OFF and everything must be cooked ON-SITE no earlier than 3 hours prior to the judging start time (12:00 PM, Saturday, September 28th, 2013) Chicken wings must be cooked from the raw state with no pre-marinating or pre-injecting. Any seasoning or ingredient necessary to create unique taste is acceptable but MUST be listed at your table (Example: Peanut Oil or a potential allergen). Signage for levels of hotness MUST also be listed at your table 1-10 scale, 10 being the hottest of the hot!!!**

*******Electricity will NOT be provided on-site so please make sure you bring sterno's for chaffing dishes, an ice chest, and/or whatever else you may need to serve them hot!**

3. Cooking - Teams **MUST** bring their own cooking equipment, pit, tents, tables, chairs, serving utensils, storage equipment, paper towels, and all other necessary serving items. This includes required signage, table decorations, and whatever else you may need for your table & tent. Bring everything you will need.

4. Selling & Tip Jars - Crime Stoppers of Tangipahoa will begin selling/registering the public for wristbands at 11:00 AM. The public will sample your wings and determine the People's Choice Award winner until you run out of product. All proceeds from the sale of the wristbands will be benefit Crime Stoppers of Tangipahoa. The suggested donation to receive a wristband is \$5.00 and will include a drink (water) and a People's Choice Award ballot. Take-out trays and napkins will be provided at the time of your registration that day. Each team will receive numbered take out trays that corresponds with its booth number issued at registration. Each team will also receive a "Tip Jar/Bucket" to place at their booth. Each booth will need/want to encourage the public to drop money in their jar when tasting the wings. Be Creative (within reason)! The team that raises the most money in their jar will win a special "Big Tipper" prize. You may also decorate your booth/team with a theme. This will make you eligible for the Best Decorated/Theme Booth Prize!

5. Judging - Ballots will determine the winner of the People's Choice Award. The ballots will be available for purchase/donation with a wristband and drink at the cook-off registration table for a suggested donation of \$5.00 each. The Big Tipper Award will be determined by the team that raises the most money in their Tip Jar/Bucket! All other awards will be determined by a panel of secret judges with wristbands who will visit your booth and sample your wings along with everyone else. You will not know who they are. Contestants will be advised of when judging begins (12:00 PM) and when awards will be presented (All Ballots must be turned in by 4:00 PM and Tip Jars will be collected at 4:00 PM as well). Awards will be announced at 4:30 PM.

6. Prizes - Prizes are non-transferable nor redeemable for cash.

7. Registration - Upon arrival at the cooking site (Zemurray Park, 400 S. Oak St., Hammond, LA 70403), the team captain must check in with Chairman at the Cook-off registration table for area assignment. **The Registration table will be open at 10:00 a.m. at which time you may set up your booth.** At that time we will provide you with any new information concerning the cook off. Registration will take place from 10:00 AM until 11:00 AM only on cook-off day.

8. Booth Set-up - Set-up time may begin at 10:00 AM. You can start cooking as soon as you register and set up at 10:00 AM, judging will not begin until 12:00 PM. Public displays and demonstrations are encouraged in order to involve the crowd and fill up your "Tip Jar" with the most money! However, decorations are not mandatory.

9. Booth Teardown - Areas must be cleaned up at the end of the event (5:00 PM). All equipment must be off the premises by 6:00 PM. Please remember to pick up your trash and place it in a trash can.

10. Application & Fees - All fees can be made payable to **CRIME STOPPERS OF TANGIPAHOA, INC.** All entry fees are non-refundable. All proceeds will benefit Crime Stoppers of Tangipahoa, Inc. a 501c3 non-profit organization and United Way Community Partner agency (TAX ID: 68-0516834).
